(c) Once complete, the employee and the facility administrator must sign a statement that the employee completed the preservice orientation which must be kept in the employee's personnel record. (d) In addition to topics that may be chosen by the facility administrator, the preservice orientation must cover: 1. Resident's rights; and, 2. The facility's license type and services offered by the facility. (3) STAFF IN-SERVICE TRAINING. This Statute or Rule is not met as evidenced by: Based on record review and interview the facility failed to provide in-service training within 30 days of employment for reporting adverse incidents for 1 of 3 (Nurse D) personnel files reviewed. The findings include: A review was conducted of Nurse D's personnel file. The surveyor was unable to locate the required education for adverse incident reporting. On at 2:20PM, an interview was conducted with the Business Office Manager. At that time, she was told that the file was missing the required adverse incident reporting education. She stated that she would go look and see what she could find. On at 3:21PM, a follow up interview was conducted with the Business Office Manager. When asked about the training for incident reporting the Business Office Manager stated that she was unable to locate any documentation stating that Nurse D had the required education.
