(k) At least 45 days' notice of relocation or termination of residency from the facility unless, for medical reasons, the resident is certified by a physician to require an emergency relocation to a facility providing a more skilled level of care or the resident engages in a pattern of conduct that is harmful or offensive to other residents. In the case of a resident who has been adjudicated mentally ill, the guardian shall be given at least 45 days' notice of a nonemergency relocation or residency termination. This Statute or Rule is not met as evidenced by: Based on observation, record review and interview the facility failed to honor the rights of one out of five sampled residents by using full bed rails without having the prescription for its use, and which the resident could not remove to get out of bed without staff assistance. (Resident #4). Findings as follow: On at 10.00 AM Resident #4 was observed in bed with full bed rails in the upright position. Resident #4's record review showed there was not a full bed rail prescription available for Resident #4. Resident had a prescription for " electric hospital bed with side rails" that did not specify the size of the bed rails. Further record review showed the resident was not under hospice care. On at 1.30 PM the Owner stated Resident #4 did not have a prescription for full bed rails but a prescription for bed rails without specifying the size of the rails was in his record. Class III	A 030
