In an interview conducted with the Executive Director on _____ at 11:10 AM, who was representing the facility licensee, she stated that the Administrator did not have access to the BGS Clearinghouse Roster to update and register the facility's current staff members. She stated that the current Administrator's access into the facility's BGS Clearinghouse Roster remained as pending. It was revealed the previous Administrator left the position in late _____ and the current Administrator commenced the new position on _____, however it was unclear who was responsible for maintaining an accurate BGS Clearinghouse Roster to ensure all staff members were included or removed if no longer employed by the facility. (8) There is no reemployment assistance or other monetary liability on the part of, and no cause of action for damages arising against, an employer that, upon notice of a disqualifying offense listed under chapter 435 or this section, terminates the person against whom the report was issued, whether or not that person has filed for an exemption with the Department of Health or the agency. 435.06 Exclusion from employment.- (1) If an employer or agency has reasonable cause to believe that grounds exist for the denial or termination of employment of any employee as a result of background screening, it shall notify the employee in writing, stating the specific record that indicates noncompliance with the standards in this chapter. It is the responsibility of the affected employee to contest his or her disqualification or to request exemption from disqualification. The only basis for contesting the disqualification is proof of mistaken identity. (2)(a) An employer may not hire, select, or otherwise allow an employee to have contact with any person that would place the employee in a role that requires background screening until the screening process is completed and demonstrates the absence of any grounds for the denial or termination of employment.
