(b) In addition to the specifications of Section 429.256(3), F.S., assistance with self-administration of medication includes, orally advising the resident of the name and dosage of the medication and verbally prompting a resident to take medications as prescribed. (c) In order to facilitate assistance with self-administration, trained staff may prepare and make available such items as water, juice, cups, and spoons. During an observation of the medication pass with Staff B (an unlicensed Medication Technician) conducted on _____ at 9:00 AM Staff B pulled the medications from the pill pack at the medication cart in the hallway outside the resident room and put them into a clear medicine cup. Staff B then entered Resident #1's room and took the medication cup with pills to her where she was seated in a chair on the far wall. Staff B did not advise Resident #1 of the dosage of medication given. During an interview on _____ at 9:03 AM Staff B stated staff do not advise the residents of the medication dosages at the time medications are given. At 9:04 AM Staff B said that sometimes she advised on the dosages of medications and sometimes she did not, but thought she was supposed to. During an interview on _____ at 8:55 AM Resident #2 stated the Medication Technicians would put her pill in a cup and not tell her what the pills were.
