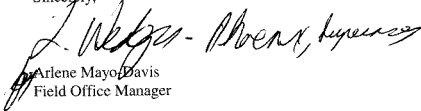
This letter reports the findings of a state licensure survey revisit conducted on November 15, 2013 by a representative from this office.
