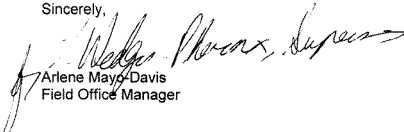
This letter reports the findings of a Desk Review conducted on August 24, 2015 by a representative of this office.
