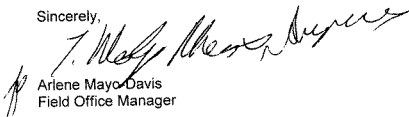
This letter reports the findings of a Change of Ownership survey revisit conducted on December 16, 2015 by a representative of this office.
