During the survey, the SA determined that the facility was in compliance with the requirements of participation in Medicare and Medicaid Services. The SA did not identify non-compliance for CI MS# 22549 for Quality of Care/Treatment related to the resident having body odor, Quality of Care/Treatment related to the resident not being groomed adequately, and Resident/Patient/Client Assessment related to resident not receiving care for a medical change in status.
