The SA did not substantiate the complaint of MS #19561 with allegations of Quality of Care/treatment inappropriate feeding assist for weight loss residents and Dietary Services and MS #19597 with allegations of Quality of Care/Treatment pressure sore precautions, call bells not answered timely, residents not groomed adequately, and services not performed per MD orders. There were no deficiencies cited. The SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid. At the time of the survey the facility census was 84 and the facility is licensed for 137 beds.	F 000
