F 000	INITIAL COMMENTS The State Agency (SA) conducted a COVID-19 Focused Infection Control Survey and a Complaint Investigation (CI), MS #20277, MS #19735, and MS #19727 at the facility from 12/27/22 to 12/29/22. The facility was found to be in compliance with infection control regulations and has implemented the Centers for Medicare and Medicaid (CMS) and the Centers for Disease Control and Prevention (CDC) recommended practices to prepare for COVID-19 and there were no deficiencies cited related to infection control. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid. MS #20277 was not substantiated for abuse, MS #19735 was not substantiated for incontinent care, pressure sores, or roaches, and MS #19727 was not substantiated for incontinent care, with no deficiencies cited. The facility is licensed for 105 beds with a census of 88 at the time of the survey.			F 000
