F 000	INITIAL COMMENTS The State Agency (SA) conducted a complaint investigation at the facility for three (3) complaints, MS #20872 for alleged neglect of a resident, not answering the facility telephone, and poor Quality of Care of Residents by staff; MS #20876 for alleged smells of feces and urine in the building, and vomit on the floor; and MS #21008 for staff refusing to assist a resident to use the restroom and she urinated on herself. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid and cited no deficiencies. The facility census on 03/22/23 was 96 and the facility was licensed for 105 beds.			F 000
