During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid. The SA investigated MS #21102 for Quality of Care/Treatment related to timing of resident medications and resident abuse and MS #21415 for Quality of Care/Treatment related to answering the call bell, incontinent care and Accidents related to unwitnessed fall and no deficiencies were cited. At the time of survey the facility was licensed for 105 beds and had a census of 94 residents.	F 000
