The facility is licensed for ten Residential Facility for Group beds for elderly and disabled persons, and/or persons with Alzheimer's disease, Category II residents. The census at the time of the survey was seven. The facility received a grade of A. One complaint was investigated: Verified without deficient practice: Complaint #NV000070021 was verified with no deficient practice. The investigation of the complaint included: -Observation of the facility, inspection of cupboards, employee file cabinets, closets, drawers, the pantry, and the kitchen. -Interviews were conducted with the Administrator, one Caregiver, and six residents. -Document review of pest control invoices and receipts. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigations, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws.
