The facility is licensed for seven Residential Facility for Group beds for elderly and disabled persons and/or persons with Alzheimer's disease, Category II residents. The census at the time of the survey was four. Four resident files and zero employee files were reviewed. The facility received a grade of A. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigations, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws. Medication, including, without limitation, any over-the-counter medication, stored at a residential facility must be stored in a locked area that is cool and dry. The caregivers employed by the facility shall ensure that any medication or medical or diagnostic equipment that may be misused or appropriated by a resident or any other unauthorized person is protected. Medications for external use only must be kept in a locked area separate from other medications. A resident who is capable of administering medication to himself or herself without supervision may keep the resident 's medication in his or her room if the medication is kept in a locked container for which the facility has been provided a key. 2. Inspector Comments: Based on observation	0920	1. Resident 1 and Resident 2's medication were secured during inspection (10/17/24). Resident 2's medication was transferred from the porch to the kitchen refrigerator (10/17/24). 2. Administrator implemented the plan that whoever is administering Resident 2's PRN medication is responsible for securing the lock on the medication box. As for Resident 1, administrator spoke to Resident 1 to always secure the medication box after taking her PRN medication. Caregivers on duty were assigned to monitor Resident 1's medication box at least three times daily. Administrator will monitor for staff and resident 1's compliance.	11/26/2024

	and interview, the facility failed to ensure resident medications were secured. Findings include: On 10/17/24 in the morning, a tour of the facility's backyard was conducted. The facility had a covered porch located at the back of the house which was used by the residents for activities and as a designated smoking area. Also on the back patio, was an extra refrigerator. Resident #2's (R2) medication box was unsecured in the patio refrigerator. There was a keyed padlock hanging from the box but the padlock shackle notch was not secured into the latch. R2's medications were unsecured in an area where the other residents could have potentially been left unattended. On 10/17/24 in the morning, Resident #1's (R1) unsecured medication bin was found on the bedroom floor beside R1's bed. The keyed padlock was not observed on the medication box. The medication box contained R1's over-the-counter (OTC) medications. R1 indicated the doctor gave them written permission to self-administer their OTC medications. The keyed padlock was observed in the medication box. R1 verified putting the padlock and key in the medication box because it was easier to get to the medications when the box was left unlocked. R1 shared a bedroom with another resident. The Administrator was present and acknowledged the medication boxes were unsecured. The Administrator indicated R1 and R2's medication boxes should have been locked. Severity: 2 Scope: 3

Inspector Comments: Based on observation and interview, the facility failed to ensure 4 of 4 exit doors had operational alarms. Findings include: On 10/17/24 in the morning, the alarms were turned off on two sliding glass doors leading to the backyard and the door leading to the garage. The Administrator turned the alarms back on during the inspectors tour of the facility. The fourth alarm was not working as expected. The facility made attempts to turn the alarm on and off but the alarm did not sound. On 10/17/24 in the morning, the Administrator acknowledged the alarms were turned off and should have been left on. The Administrator acknowledged the fourth alarm was not working as expected and indicated the facility would purchase new alarms. Severity: 2 Scope: 3	0991	1. The alarms on both sliding doors and the door leading to the garage were turned on during inspection (10/17/2024) and a new alarm was bought and installed on the doors leading upstairs (10/22/24). 2. Administrator told the staff to leave the alarms on at all times and report to administrator any faulty or inoperable alarms immediately. Extra pair of alarms were bought in case any of the alarms needed to be replaced (10/22/24). Staff on duty are responsible in ensuring that these alarms are on. On 10/17/24 in the morning, the Administrator acknowledged the various piles of debris accumulated in the backyard. The Administrator revealed the former patient information was supposed to be thrown in the trash. The Administrator revealed the facility obtained the cat for rodent control, but there was no litter box available for the cat. Severity: 2 Scope: 3	0178	1.All the boxes and materials found around the shed during inspection came from inside the shed as staff cleared the shed to go through the things that needed to be thrown away. After sorting all the boxes, bags, and things, those that were not needed were thrown away including the incontinence undergarments, books, binders, and warped wood used as a walkway on the side of the shed (10/26/2024). Patient information was shredded before discarding it ((10/17/24) and cat litter was bought and placed down the stairs of the abandoned room (10/17/24). 2. Administrator told staff to keep backyard free of clutter when clearing the shed. Staff are to store things that are only certain to be used in the future to prevent accumulation of things inside the shed. Quarterly checks on stored patient files will ensure that they will be disposed of properly in a timely manner. Weekly cleaning will be done in the abandoned room.
